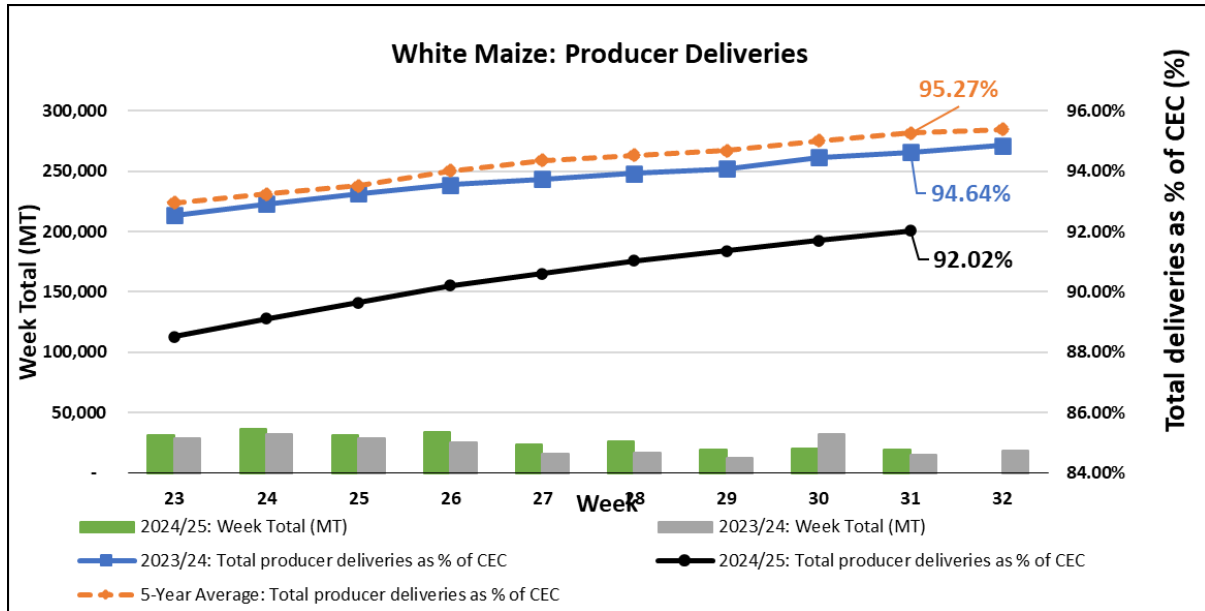




Date: 4 December 2024 SAGIS Weekly Producer Deliveries

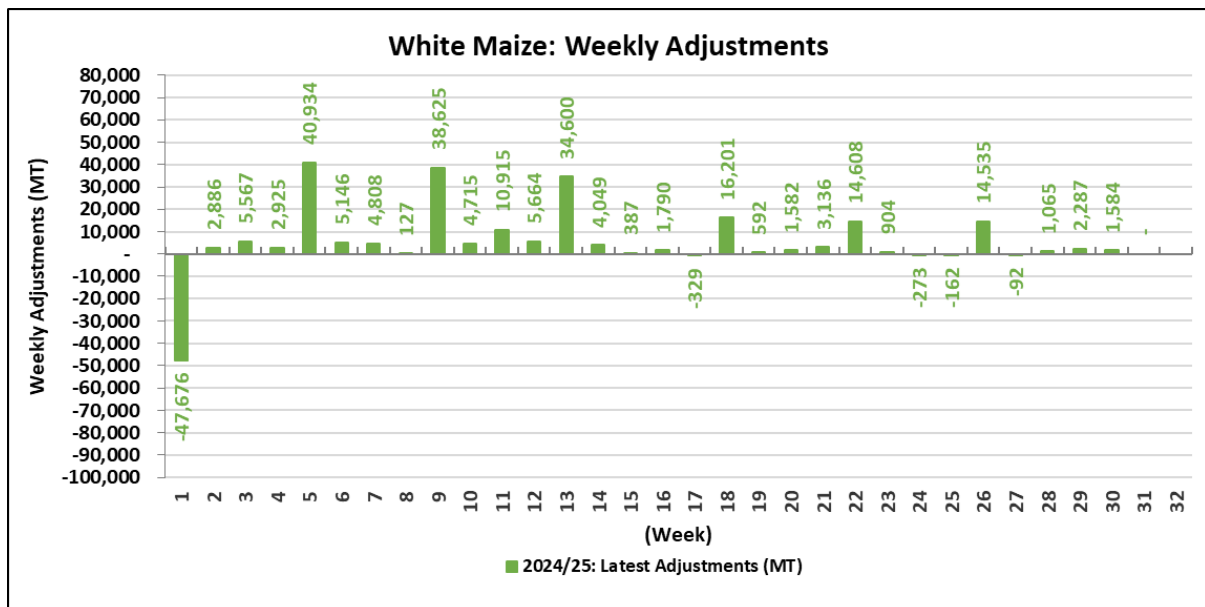


Figure 2: White Maize: Latest weekly adjustments (MT)

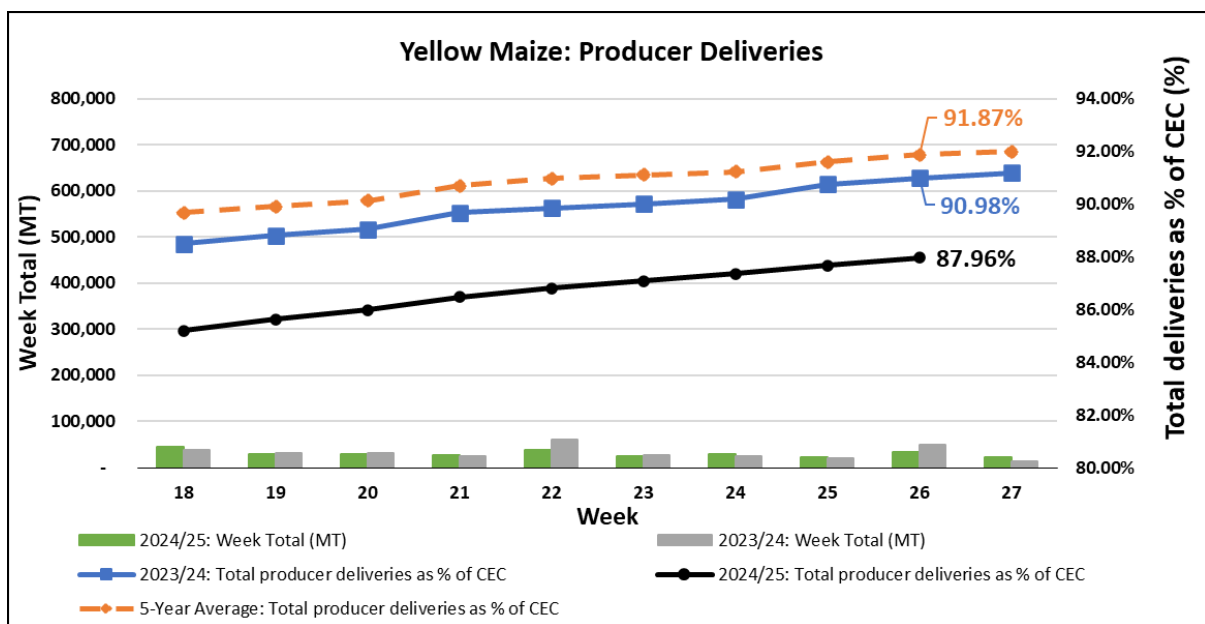

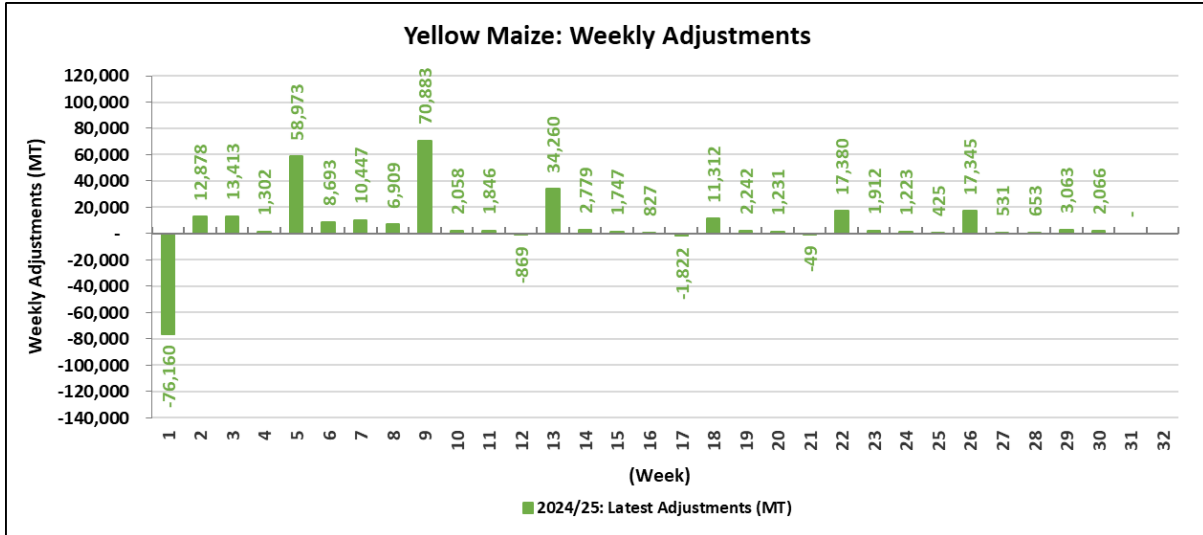


Figure 4: Yellow Maize: Latest weekly adjustments (MT)

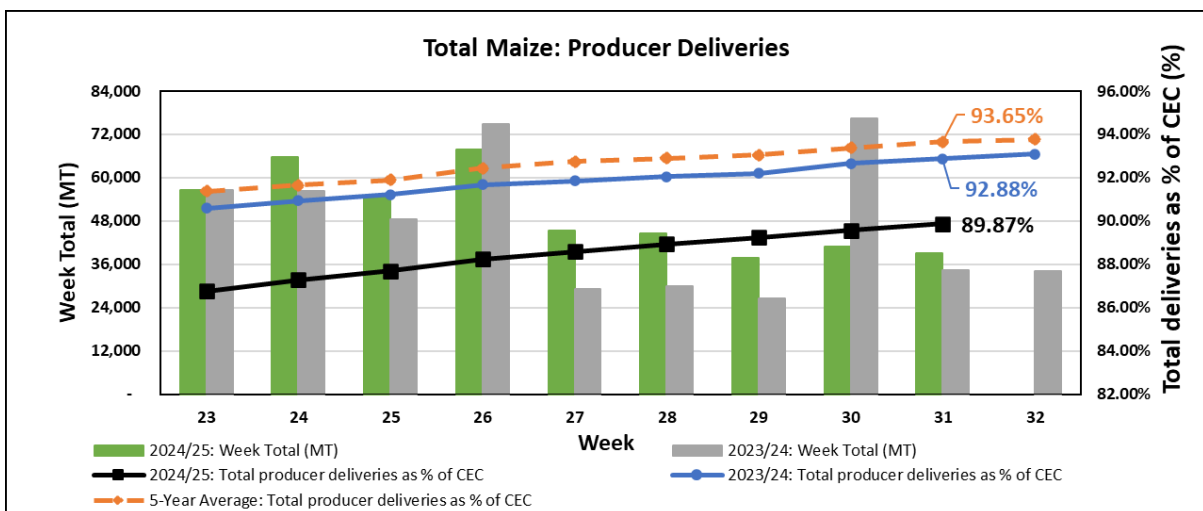

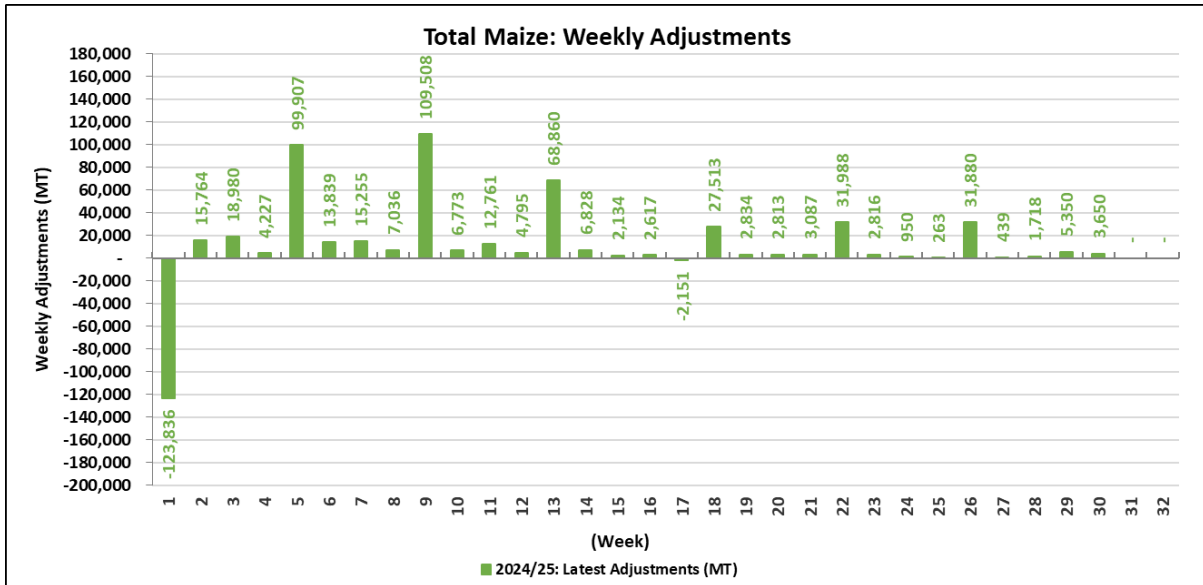


Figure 6: Total Maize: Latest weekly adjustments (MT)

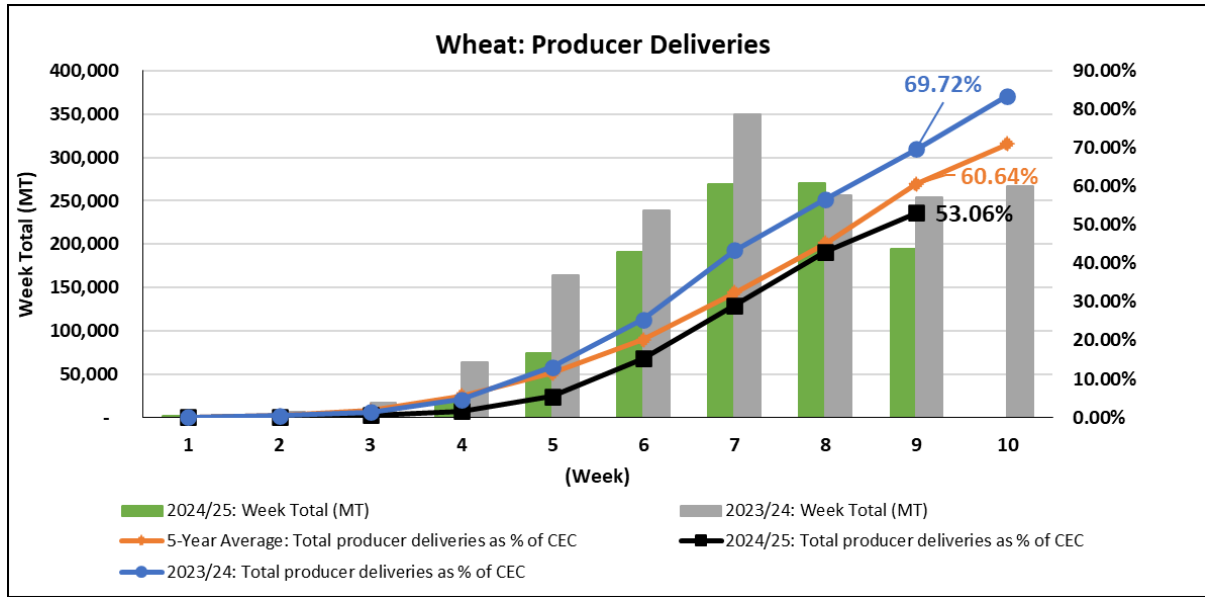


Figure 7: Wheat: Producer deliveries (MT)

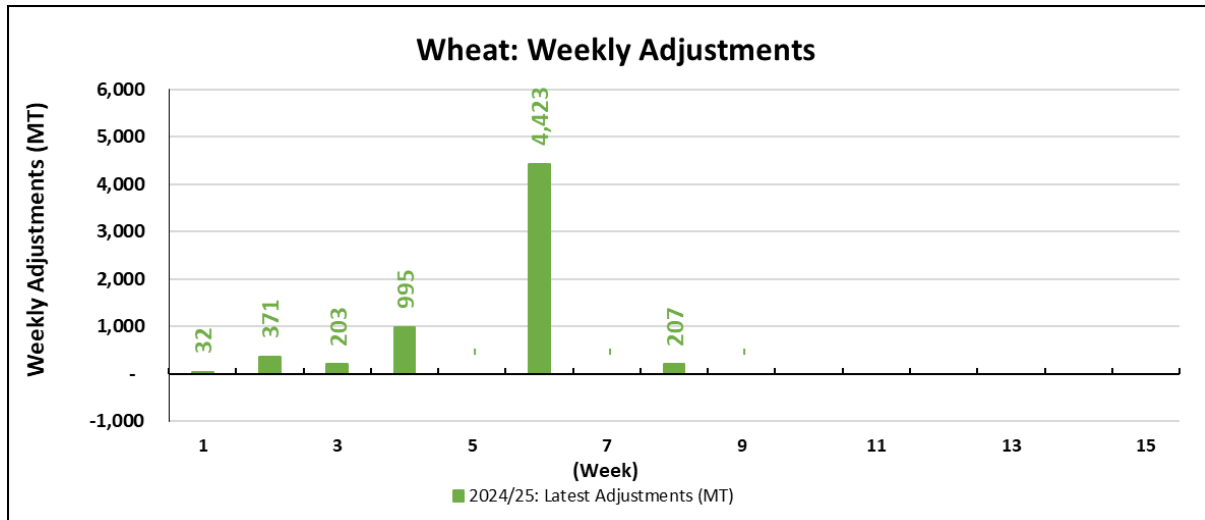


Figure 8: Wheat: Latest weekly adjustments (MT)

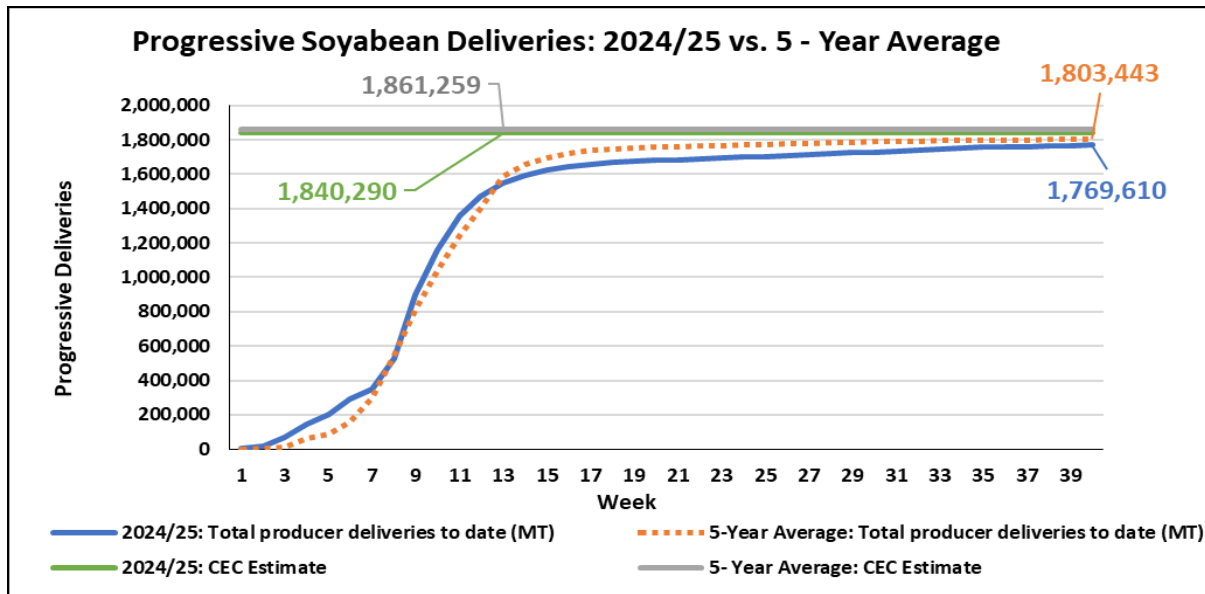


Figure 9: Soybeans: Producer deliveries (MT)

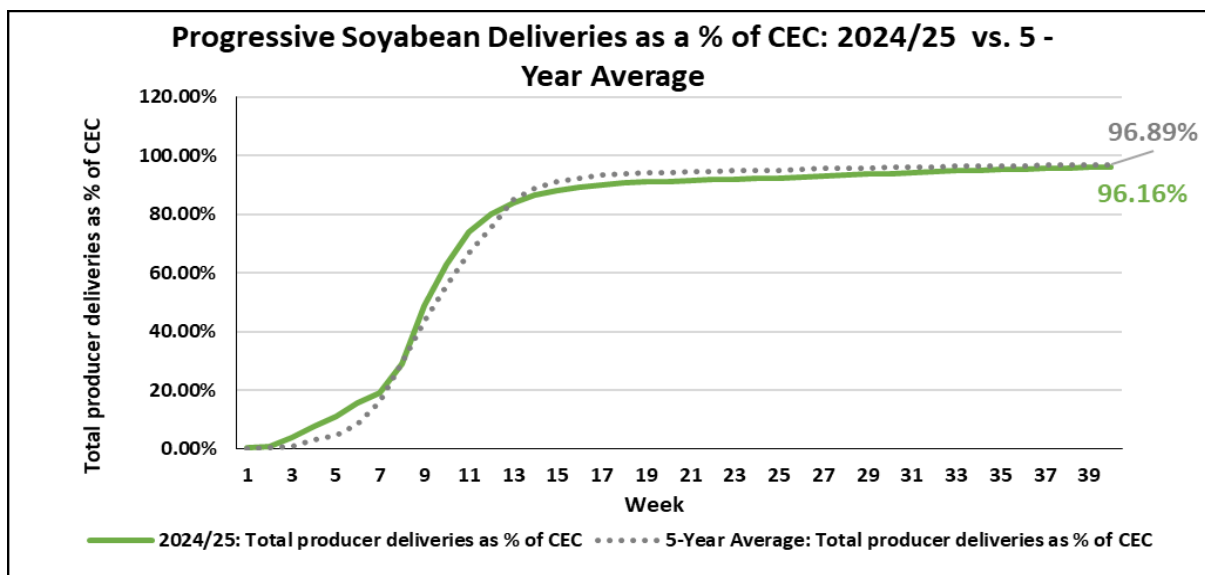


Figure 10: Soybeans: Producer deliveries (MT)

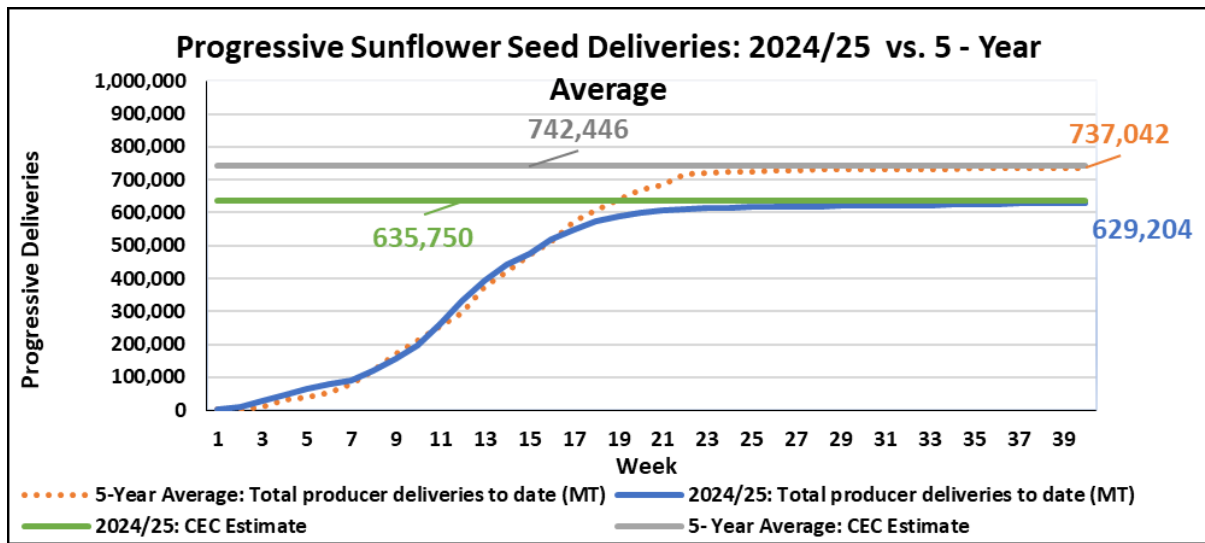


Figure 11: Sunflower Seed: Producer deliveries (MT)

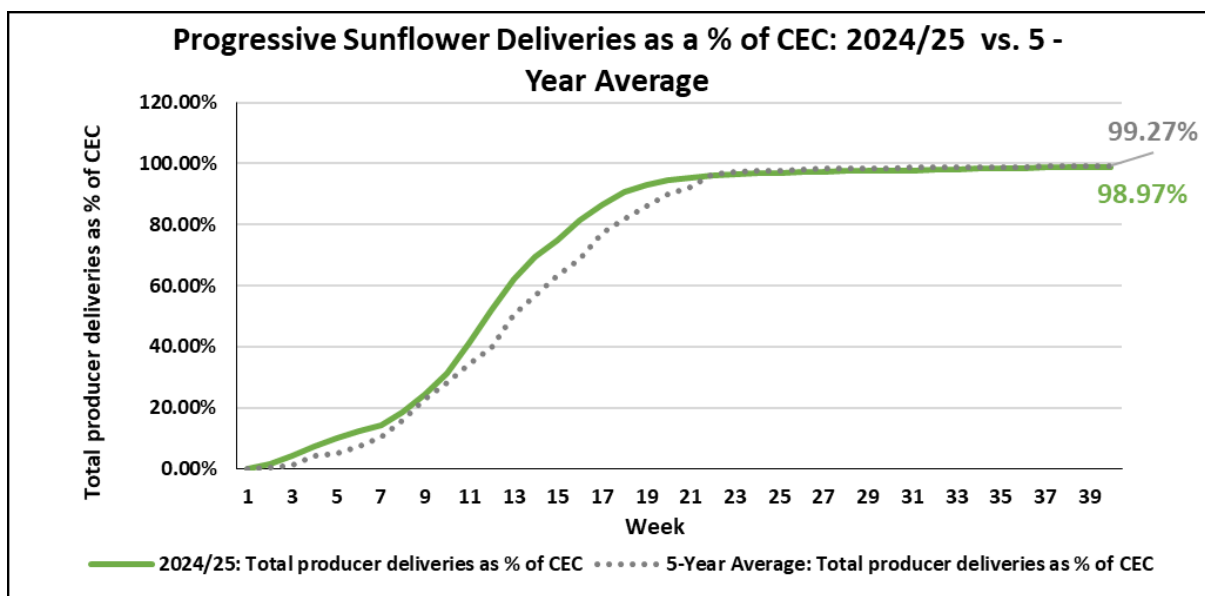


Figure 12: Sunflower Seed: Producer deliveries (MT)
